California Missing Children Clearinghouse

The California Missing Children Clearinghouse maintains a toll-free telephone hotline (1-800-222-FIND) 24-hours-a-day, seven-days-a-week to receive information and inquiries regarding missing children. It relays this information to the appropriate law enforcement agencies.

The Clearinghouse works closely with the National Center for Missing and Exploited Children to aid in locating children who have been abducted and taken out of California or brought into California. The Clearinghouse publishes and distributes a monthly poster and quarterly bulletin featuring missing children throughout California. The posters and bulletins are distributed to all California police and sheriff's departments, California Highway Patrol offices, district attorneys' offices, public primary and secondary schools, private primary schools, hospitals, state agencies, road side rest stops, other missing children clearinghouses nationwide and other parties determined appropriate by the Department of Justice.

In California, a missing child is defined as an individual whose whereabouts are unknown to the reporting party and includes, but is not limited to, any child missing voluntarily, involuntarily, under circumstances not conforming to their ordinary habits or behavior, and who may be in need of assistance. It also includes a child taken, retained, concealed, enticed away or retained by a parent.

There is no waiting period for reporting a child missing. All California police and sheriffs' departments will accept any report, including any telephonic report, of a missing person, including runaways, without delay and will give priority to the handling of the report.

Student Survey on Drug and Alcohol Use.

Attorney General Lockyer issues Eighth Biennial California Student Survey showing overall drug and alcohol use by students down for first time in a decade, but 11th graders experimenting with heroin. Survey suggests need for continued prevention efforts and attention to helping students with substance abuse problems. Survey co-sponsored by California Department of Education, Department of Health Services and Department of Alcohol and Drug Programs.

Civil Rights

The new annual report, Hate Crimes in California, 1999, provides the latest statistics. Reported hate crimes in 1999 increased by 12.1% over 1998. Crime & Violence Prevention

Safe from the Start is a new cooperative effort of the Attorney General, California Children and Families Commission and California Health and Human Services Agency to focus attention on helping children victimized or exposed to violence. As explained by Attorney General Lockyer: "Safe from the Start is an historic effort aimed at stopping the cycle of violence and protecting our kids from its impact. With evidence showing that a child has a one in four chance of being victimized or exposed to family or community violence by the age of 18, the need to act is now."

Gasoline Prices

Attorney General Lockyer issued a Report on Gasoline Pricing in California, summarizing task force discussions held earlier this year and calling for reasonable steps to restore healthy, vigorous competition in the market, as well as increase conservation and alternative fuel opportunities.

Tobacco Litigation

Information and links are available regarding the landmark lawsuit against the tobacco industry, including the settlement agreements that restrict marketing practices and provide \$206 billion to California and 45 other states.

Charities

Nearly one-eighth of all charities in the United States are registered in California. Using the <u>Charities Data Base</u>, you can find the names of charities registered in California and the most recently filed IRS 990 financial reports filed with the Attorney General's Registry of Charitable Trusts.
